1.8.6 **Sports Field Agreement:** A copy of the sport's field agreement is to be given to the football club who will then speak with the cricket club.

1.8.7 **Overhanging vegetation:** Resolved that this will be trimmed by the parish council.

1.8.9 **Village Post Office:** We have been contacted by the Post Office who has said it may be possible to host a post office in the village hall, which they

will come to assess at a later date. They will contact us again at the end of March.

1.8.10 **Ruined Verges:** After verges have been ruined by construction vehicles associated with building works, or villagers and visitors parking on them or using them for passing we previously resolved that boulders would be put in from the edge to protect them. This would be a temporary measure and they would be put where needed after the verges have been repaired. A quotation for the repair of some of the verges has been obtained we will obtain the remaining costs for repair.

- 1.8.13 **Water running down road from Lone Tree into Lower End:** This may be caused by overflowing drains or a spring or because the road was not gritted. Highways to be informed.

1.8.14 **Tourist sign for The Two Brewers:** Highways has replied to our request for a tourist sign; an application form has to be completed and sent back to them along with an assessment fee. It was resolved that we would go ahead with the application.

- 1.8.17 **Repair to Parish Pump outside Forge Cottage:** The pump has now been repaired by Martin Thomas.
- 1.8.20 **Diversions when A421 is closed:** When part of the A421 was closed recently traffic was diverted along Lower End and along Leckampstead Road instead of through Great Horwood. It is thought that the police do not always know of the correct diversion route. Alex Keeling will mention the subject at the next NAG meeting.

- 1.8.22 **Group against Greenway:** A planning application has been submitted by Greenway Land to build a new town on the site of the former wartime airfield near Winslow. There would be at least 3,000 new houses. The new town would be twice the size of Winslow. After discussion the council resolved to write a letter to AVDC objecting to the planned town.
